**Subject: Consideration and action on a resolution canvassing the results of the General Election held on May 2, 2026 for the purpose of election a Councilmember to Place 4 on the Greenville City Council, and to canvass the results of the Special Election on proposed amendments to the Greenville City Charter; tabulating the returns; and declaring the results of the election in accordance with *Texas Election Code 67.004(a)* (City Council)**

### 1. Background/History:

The City Council ordered a General Election for the purpose of electing Councilmembers to Place 3 and Place 4 and a Special Election for Amendments to the City Charter on January 27, 2026, by Ordinance 26-001. The City Council approved Ordinance 26-008 and issued an Order of Cancellation on February 24, 2026, for the Place 3 General Election due to the unopposed status of the candidate.

Since the election is over, the next step in the election process is to canvass the votes for the Place 4 election and the Special Election results of Charter Amendments to the City Charter of the May 2, 2026 election. The canvass is the official tabulation of the election results.

### 2. Findings/Current Activity

The canvass for the May 2, 2026, election must be held no earlier than May 5, 2026, and no later than May 13, 2026. [EC §67.003]

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GREENVILLE, TEXAS, CANVASSING AND DELCARING THE RESULTS OF THE GENERAL ELECTION HELD ON MAY 2, 2026, FOR THE PURPOSE OF ELECTING A COUNCILMEMBER TO PLACE 4 ON THE CITY COUNCIL OF GREENVILLE, TEXAS, AND A SPECIAL ELECTION RELATED TO AMENDMENTS OF THE CITY OF GREENVILLE CHARTER; DETERMINING THE NUMBER OF VOTES CAST; AND DIRECTING THE CITY SECRETARY TO RECORD RESULTS IN THE OFFICIAL ELECTION REGISTER OF THE CITY OF GREENVILLE, TEXAS; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, on May 2, 2026, a General and Special Election was held for the purpose of electing a Councilmember to Place 4 on the Greenville City Council and to consider amendments to the City of Greenville Charter; and

**WHEREAS**, public notice of such election was duly given, and such election was duly and properly held and administered in accordance with the laws of the State of Texas and the Charter of the City of Greenville, Texas; and

**WHEREAS**, the City Council has met on this date, and the returns of the election have been made to the City Council by the election officer in strict conformity with law, and the City Council has carefully and accurately examined and canvassed the returns and tabulated the results on the election.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GREENVILLE, TEXAS, THAT:**

**SECTION 1.** A canvass of the returns of the general election, and a tabulation of the votes cast therein for the candidate for office, as the names of the candidates appeared on the official ballot, therefore, reflects and discloses, and the governing body hereby finds and determines, that the number of votes cast for each candidate in the affected voting district within the City are shown in the attached Exhibit “A” and as stated below:
